WINDOWPAIN - FOREST CITY WINDOWS CONTEST RULES

THE WINDOWPAIN - FOREST CITY WINDOWS CONTEST (THE "**CONTEST**") WILL BE CONDUCTED IN THE PROVINCE OF ONTARIO ONLY AND SHALL BE CONSTRUED AND EVALUATED ACCORDING TO APPLICABLE CANADIAN LAW. NO PURCHASE IS NECESSARY. ENTRANTS MUST BE OF THE AGE OF MAJORITY IN THE PROVINCE OF ONTARIO OR OLDER AT THE TIME OF ENTRY. VOID IN WHOLE OR PART WHERE PROHIBITED BY LAW. ENTRY IN THIS CONTEST CONSTITUTES ACCEPTANCE OF THESE CONTEST RULES (THE "**CONTEST RULES**").

1. ELIGIBILITY.

- 1.1 To be eligible for this Contest, an individual must:
 - (a) be a legal resident of the province of Ontario;
 - (b) be of the age of majority in the province of Ontario or older at time of entry;
 - (c) be the sole owner of all right, title and interest (including copyright) in and to the Work (as defined below) submitted in connection with the Contest; and
 - (d) be the legal owner of a house that is located within sixty kilometers (60km) of the city of London, Ontario.
 - (e) Winner must own home
 - (f) Must be residential structure
 - (g) Winner must live within 60kms of London
 - (h) Winner must utilise prize within 12-months from date of winning
 - (i) Winnings have no cash value
 - (j) Cannot be part of a condo corporation
 - (k) Must have not won a prize within 30 days valued over \$1,000 CDN
- 1.2 The following people are not eligible to enter the Contest:
 - (a) Employees of Corus Radio Inc., operating as CHFK-FM and CFPL-FM (the "**Station**") and its parent, affiliates, subsidiaries, related companies, successors and assigns (together with the Station, "**Corus**");
 - (b) Employees of Forest City Window & Door Ltd, its affiliates, subsidiaries, related companies, successors and assigns (collectively, "Forest City Windows", together with Corus, the "Sponsors");
 - (c) Judges (as defined in Section 6 below) of the Contest;
 - (d) Any person who has been confirmed as a winner of two (2) Corus administered contests within six (6) months preceding the Contest start date indicated below where the prize was valued over one thousand Canadian dollars (CDN\$1,000); and
 - (e) The household members of any of the parties listed in Section (a) to (d) above.

- 1.3 The Sponsors shall have the right at any time to require proof of identity and/or eligibility to participate in the Contest. Failure to provide such proof may result in disqualification. All personal and other information requested by and supplied to the Sponsors for the purpose of the Contest must be truthful, complete, accurate and in no way misleading. The Sponsors reserve the right, in their sole discretion, to disqualify any entrant should such an entrant at any stage supply information that does not meet these requirements.
- 2. CONTEST PERIOD. The Contest begins at 12:00a.m. Eastern Time ("ET") on May 12, 2025 and ends at 11:59 pm ET on May 23, 2025 (the "Contest Period") after which time the Contest will be closed and no further entries shall be accepted.

3. HOW TO ENTER.

- 3.1 There is no purchase necessary to enter the Contest. Enter using the method of entry outlined below. No entries will be accepted by any other means.
 - (a) To enter online, complete and submit the entry form located at <u>www.fm96.com</u> and <u>www.1031freshradio.ca</u> (together, the "**Contest Microsites**" each, a "**Contest Microsite**").
- 3.2 Each entrant must submit an entry form together with short essay, with a maximum on one thousand (1,000) words on why they deserve to win up to ten thousand Canadian dollars (CDN\$10,000) worth of window services from Forest City Windows & Doors (the "**Work**").
- 3.3 By participating in this Contest, each entrant represents and warrants that the Work: (i) does not contain any material, language or gestures that are libelous, defamatory, indecent, profane, obscene or violent and does not violate any laws including without limitation, relating to hate speech or otherwise; (ii) is original, solely created by the entrant and that no third party participated as an author, co-author or otherwise in the creation of the Work or any part thereof; (iii) all right, title and interest (including copyright) therein is owned and/or controlled by the entrant to the full extent necessary to enable the Sponsors to use the Work as contemplated by these Contest Rules; (iv) the Work does not infringe upon the intellectual property rights, rights of publicity, privacy rights, proprietary interests or other statutory or common law rights of any third party; (v) does not contain any recognizable logos or any other copyrighted material; (vi) does not contain any mention, endorsement, or "plug" any commercial product, service, venture or thing, including, without limitation, the name of entrant's employer; and (vii) has not been submitted in connection with any other contest and/or promotional campaign.
- 3.4 Limit of one (1) entry per person during the Contest Period. In the case of multiple entries, only the first eligible entry will be considered.
- 3.5 All entries including the Work, become the sole property of the Sponsors and will not be returned for any reason. Entries must be received no later than the end of the Contest Period. Entries will be declared invalid if they are late, illegible, incomplete, damaged, irregular, mutilated, forged, garbled or mechanically or electronically reproduced. Unless otherwise set out herein, no communication or correspondence will be exchanged with entrants except with those selected as a potential winner.
- 3.6 Entries received online shall be deemed to be submitted by the authorized account holder of the email address associated with the entry. For the purpose of the Contest Rules, "authorized account

holder" of an e-mail address is defined as the natural person who is assigned to an e-mail address by an Internet access provider, on-line service provider, or other organization responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. Any entrant may be required to provide the Sponsors with proof that they are the authorized account holder of the e-mail address associated with their entry.

4. PRIZE.

- 4.1 There is one (1) prize (the "**Prize**") available to be won by the Prize winner (the "**Winner**") consisting of:
 - (a) Ten thousand Canadian dollars (CDN\$10,000) worth of services towards a new windows.
- 4.2 Winner is not entitled to monetary difference between actual Prize value and stated approximate Prize value, if any.
- 4.3 The Sponsors and/or the Sponsors' representatives will contact the Winner to coordinate the provision of the Prize within three (3) days once such Winner has been successfully contacted and notified of their Prize and fulfilled the requirements set out herein.

5. PRIZE CONDITIONS.

- 5.1 The Prize is only valid for window services on a residential structure (excluding structures that are part of a condo corporation), that is legally owned by the Winner and is inclusive of material and labour.
- 5.2 Prize must be accepted as awarded and cannot be transferred, assigned, substituted or redeemed for cash, except at the sole discretion of the Sponsors. Any unused, unclaimed or declined portion of the Prize will be forfeited, have no cash value and the Sponsors shall have no obligation to provide either an alternative or value-in-kind. The Sponsors reserve the right, in their sole discretion, to substitute a prize of equal or greater value if a Prize (or any portion thereof) cannot be awarded for any reason.
- 5.3 Shipped Prizes shall not be insured and the Sponsors shall not assume any liability for lost, damaged or misdirected Prizes.

6. SELECTION.

- 6.1 One (1) Winner shall be selected as follows:
 - (a) On or about *day, date, year* in London Ontario, One (1) entrant will selected by the Sponsors and or the Sponsors' representatives (the "Judges") based on the following equally weighted criteria: Compelling Nature of the Story (the "Criteria"). Each entrant shall be eligible to win only one (1) Prize. The odds of being selected as a potential winner are dependent upon the number of eligible entries received by Corus OR the Sponsors and the application of the Criteria to eligible entries by the Judges. Before being declared a Winner, the selected entrant shall be required to comply with the Contest Rules and to sign and return the Release (as described below).
 - (b) The Judges, in their absolute discretion, shall select the Winner based upon the above

Criteria. The decisions of the Judges shall be final and binding and may not be challenged in any way.

- (c) THE SELECTED ENTRANT WILL BE NOTIFIED BY TELEPHONE AND/OR E-MAIL NO LATER THAN MAY 26, 2025 AT 10:00 am ET AND MUST RESPOND WITHIN THREE (3) BUSINESS DAYS OF NOTIFICATION. Upon notification, the selected entrant must respond by telephone or e-mail (as specified in the notification) to the contact number or e-mail address provided no later than the indicated deadline set out in the Contest Rules and/or the notification. If the selected entrant does not respond accordingly, they will be disqualified and will not receive *a/the* Prize and another entrant may be selected in the Sponsors' sole discretion until such time as an entrant satisfies the terms set out herein. The Sponsors are not responsible for the failure for any reason whatsoever of a selected entrant to receive notification or for the Sponsors to receive a selected entrant's response.
- (d) If, as a result of an error relating to the entry process, drawing or any other aspect of the Contest, there are more selected entrants than contemplated in these Contest Rules, there will be a random draw amongst all eligible Prize claimants after the Contest's closing date to award the correct number of Prizes.
